In the News

An article by <u>Tom Hudson</u> and <u>Eric Johnson</u> titled "<u>Maryland Case Highlights Reasons to</u> <u>Distinguish Between Loans and Installment Contracts</u>" appeared in the April edition of *RV News*. An article in American Banker titled "<u>It 'would stab a knife' into CFPB: Critics react</u> to <u>Mulvaney proposal</u>" that ran on April 2 quoted <u>Allen Denson</u>. The article discusses how the Consumer Financial Protection Bureau (CFPB) acting director's recent proposal that all CFPB rules be subject to congressional approval baffled many observers.

On April 20, Allen's <u>opinion piece</u> about the urgency for the current administration to nominate a permanent head of the CFPB, published in *American Banker*'s Bank Think section. According to Allen, "Having a permanent director is critical because the president cannot simply award Mr. Mulvaney a second 210-day term. To not name a permanent director - who would serve a five-year term - risks ceding that ability to the opposing party, or at the very least watering down his ability to name a long-term leader in his ideological vein."

Also on April 20, a *Wall Street Journal* article quoted <u>Lucy Morris</u> on the largest banking fine of the Trump era against Wells Fargo over claims of misconduct in its auto and mortgage lending businesses. "'There is much doubt that enforcement actions will be at the same pace' as under the previous leadership," she said.
