#### Hudson Cook Notable Achievements

<u>Rebecca Kuehn</u> and <u>Allen Denson</u>, partners in the Washington, D.C., office of Hudson Cook, filed an amicus brief in the Supreme Court of the United States on behalf of the Consumer Data Industry

Association (CDIA) in support of a Petition for a Writ of Certiorari in *Spokeo, Inc. v. Robins*. In the amicus brief, Kuehn and Denson argued on behalf of the CDIA that the Ninth Circuit's decision had deepened a significant split among lower courts, which differ on whether plaintiffs must suffer a "real world" harm versus a hypothetical risk of harm to proceed with a lawsuit in federal court.
