In March, <u>Eric Johnson</u> attended and moderated the National Automotive Finance Association's Quarterly Compliance Roundtable meeting at the Automobile Acceptance Corporation's (AAC) offices. Jean Noonan gave a presentation to the <u>Association of Consumer Vehicle Lessors</u> on March 7 on the Department of Justice's enforcement action against BMW Financial Services, alleging violations of the Servicemembers Civil Relief Act (SCRA). The first-on-this-issue settlement resolved claims that the SCRA's requirement to refund amounts "paid in advance" to service members who terminate their leases early includes not only rental amounts paid in advance, but also a portion of the capital cost reduction paid at inception of the lease.

<u>Allen Denson</u> spoke to the <u>Small Business Finance Association</u> on March 20 about Consumer Financial Protection Bureau (CFPB) and state attorney general updates.

<u>Kate Fisher</u> recently attended a meeting of the <u>International Factoring Association</u> in New York City on behalf of the Alternative Finance Bar Association (AFBA) - she is the treasurer of the AFBA.

On March 23, Lucy Morris appeared on a panel before the U.S. Chamber of Commerce on
